 - Branch
 - City
 - o And (Swift Code, Sort Key, Routing Number) if available.

Requirements for suppliers from Qatar:

- A valid copy of the Commercial Registration (CR) Certificate
- A valid copy of the Tax Card
- A valid copy of the ICV (If applicable to your organization)
- A valid copy of the Establishment Card (Optional)
- A valid copy of the Trade License
